

Bay Area* Nonprofit Regional Profile

Causes Count analyzed 72,478 California nonprofits (50,000 of which are all or nearly all volunteer) and gathered input from 3,000+ nonprofit leaders and individuals across the state.

Key findings from the study indicate that California nonprofits:

- Generate the majority of their revenue through programs and fees
- Contribute 15% to the Gross State Product (GSP)
- Are the 4th largest private employer by industry in the state
- Employ a racially diverse and younger workforce
- Have fewer resources in Southern California
- Operate in the black or at break even 70% of the time
- Mobilize 25% of the state's residents as volunteers
- Are trusted more than for-profits to create jobs, reflect community values, and work on the public's behalf.



This regional profile provides specific, local information drawn from *Causes Count* data sources. **What's unique about the Bay Area Region?** It is home to 19% of the state's population, 28% of its nonprofits, and 53% of its total nonprofit revenue. It has the largest number of foundations and highest annual giving of all other regions in the state. Notably, the region's health organizations (other than hospitals) generate 74% of the total nonprofit health revenue in the state.


